### Update from DC Water: Albemarle and 32<sup>nd</sup> Street Manhole Project

The Soapstone project has reached a significant milestone with the successful installation of Shot

#10, the final segment of cured-in-place pipe (CIPP). This achievement marks an important step in strengthening the reliability of the sewer system. In addition, one of the bypass pumps has been removed, the crosswalk at Connecticut Avenue and Albemarle Street has reopened for pedestrian use, and all planned tree removals have been completed. Crews will also begin cleanup activities in and around the work zone at the area around the crosswalk.

Looking ahead, work will continue on the new manhole, beginning with the concrete base pour and moving into vertical construction. Site restoration and final landscaping will follow in the coming weeks as the project advances toward completion.

We appreciate the community's patience and support as we approach the final stages of this important infrastructure project.

### Update from Councilmember Frumin's office

#### **TANF Pass-Through Funding Update:**

- Councilmember Frumin, announced that, beginning October 1, 2025, families receiving Temporary Assistance for Needy Families (TANF) will see an increase in child support passthrough payments from \$150 to \$200 per month.
- This change, enacted through the Child Support Reform Amendment Act of 2025, ensures more money collected from noncustodial parents goes directly into the hands of District families.

**Motor Vehicle Theft** - 1 - 3000 Tilden Avenue NW - 50% decrease.

**Theft From Auto** - 8 - 47% decrease.

**Thefts including Retail Thefts** - 25 - 38% decrease.
