1. Commissioner Imtiaz provided instructions for public participation in the meeting.
2. The meeting was held virtually via Zoom and began at 7:01pm ET with a quorum with 4 Commissioners present.
3. Commissioner Bloomberg motioned to approve the amended agenda, Commissioner Vining seconded the motion.
  - a. Motion to approve the amended agenda passed via voice vote with a 4-0-0 vote: Commissioner Lewis (Y), Commissioner Bloomberg (Y), Commissioner Imtiaz (Y), Commissioner Vining (Y).
