- 1. H Street Main Street NE, Public space improvements- Mr. Saleem is seeking ANC support for public space improvements on the H Street corridor. Recommendation to support the improvements.
- 2. 1232 4th Street NE (TOPS 447270), paving, curb, gutter, and sidewalks- The applicant requests a permit for public space improvements including electric vaults, new curb and gutter, closure of existing driveway, bike racks, new trees and plantings, benches, balcony, and bay window. Planning, Zoning, and Economic Development Committee (Mark Eckenwiler, Chair)

- 1. 502 C Street NE (HPA 25-325)- Concept approval to renovate three-story mixed-use structure and enlarge new three-story rear addition. Recommendation to support the proposal with strict conditions regarding a better-defined roof line, a suggestion to rework alternating bands of stone panels, and authorize Commissioner Eckenwiler to act as a witness and designate Commissioner Eckenwiler as representative.
- 2. 409 East Capitol Street NE (BZA 213333)- Special exception and use variance to construct a third story rear addition and a second dwelling unit, and convert the first floor to office use at an attached mixed-use two-story building. Recommendation is to support the application without conditions and designate Commissioner Eckenwiler as a witness.
- 3. 1128 4th Street NE (BZA 21329)- Special exception for after-the-fact approval of an illegally constructed railing atop a porch roof. Recommendation is to oppose the exception.

1. Wolfgang Puck Bar + Bites, ABRA-13203, 50 Massachusetts Ave NE, Class C restaurant. Recommendation is to oppose the license to allow for negotiation of a stipulated agreement, and to provide a letter of support for the stipulated license, as well as designate Michael Upright and Drew Courtney as witnesses.
