Approval of the Agenda

The agenda was approved by general consent.

Government Announcements

As the Public Safety Report was not ready, the Commission heard from Noah Glasgow, Ward 6 MOCRS, out of turn. He discussed issues related to the Mayor’s relationship with the National Guard troops.

Jeanne Mattison, of Councilmember Allen’s office, reported that Councilmember has been meeting with members of Congress regarding the recent Federal intervention in the District. July 2025 Minutes

The July 2025 minutes were **approved** as submitted without objection.

Consent Agenda

The Commission **approved support** for the Army Ten Miler and the Race for Every Child and **ratified** the settlement agreement with the Theater Alliance by general consent.

ABC Matters

Michael King, chairman of the ABC Committee, summarized the Committee's written report. The Commission then **voted** without opposition to accept the recommendation of the Committee **to approve the settlement agreements** for **bartaco, Pink Tiger, and Potomac Paddle**. Next the Commission **voted** without opposition to accept the recommendation of the Committee **to take no action** on the renewal application of **Union Stage**. Finally, the Commission again **voted** without opposition to accept the recommendation of the Committee **to protest** the application of **12 Stories** on the grounds of peace, order, and quiet.

Pepco Steam Plant

Mignon Bowie, Pepco Sr. External Affairs Specialist, and several other Pepco officials updated the Commission on the progress of Pepco's abatement and fence replacement project. Following their presentation, Commissioners demanded to know why Pepco could not provide the air monitoring data to the ANC that Pepco is submitting to the Department of Energy and Environment. The Pepco representatives ended their discussion by saying that they would consult further with their legal counsel and report back.

Youth Initiative Discretionary Fund

No motion was offered regarding this topic and the Commission continued to the next item.

He then adjourned meeting at approximately 8:55 pm.
