Commission Announcements and Community Discussion

- Join the Ward 8 Faith Leaders Juneteenth Breakfast
- 8A03 is working to clean up Minnesota Ave corridor and working with small businesses, MPD, and others
- Morris Road residents advocated for DPW / DDOT to improve the alley infrastructure, and MOCRS replied that it is a private alley and the process would need to include the owners to turn over the property. There may be some funding in the budget for improvements.
- WMATA bus routes are changing starting this summer
- 8A02 is continuing to work on improving park infrastructure along Minnesota Ave
- 8A07 working on park clean-ups and starting communication with W8 Woods to support. Meeting with the new ownership of Marbury Plaza and DOB (MP name rechanged to Langston Views). Expressed frustration with DOB communication.
- 8A01 announcement: construction and planned reconstruction along 19th Street and zoning for a new building coming to the community

MPD Update

- 7D and 6D provided crime stats updates. Stats can be found here: https://crimecards.dc.gov/
- Presenters: Captain Pulliam (Sector 1), Captain Carlene Model ("Thrive" Captain)
 - Violent incidents increased due to citywide events; specific hotspots include 16th & W,
 Galen Terrace, Wade Road, 14th & Marion Barry Ave.
 - o MPD Strategy: Targeted deployment, footbeats, multi-agency coordination, nuisance property enforcement with OAG.
 - o Community Engagement: Walks and increased camera surveillance; next walk June 12 at 16th & W.
 - Commissioner Concerns: Lack of incident notifications; request restoration of ANC briefings and communication protocol.

Presenters:

Go-Go Museum: Juneteenth Jubilee & ABCA License Support | Ron Motem

- Presented the Anacostia Renaissance Juneteenth Jubilee, which included arts and cultural activation across Anacostia, a Freedom Walk across the 11th Street Bridge, and reenactment and performances by young people.
- Requested \$1,500 grant for Juneteenth event—Approved Unanimously
- Provided an updated Liquor License Request for the Café; need temporary license for 45 days while awaiting full approval—Approved Unanimously

Anchor Destination at Poplar Point: Therme | Presenters: John Altshuler (CEO, Therma), Wanda Lockridge (Local Liaison)

- Project Overview: Wellness-focused complex including spa, family waterpark, restaurants.
- Community Concerns Raised: Affordability, RFP selection process transparency (receiving confusing information in terms of whether Therme is awarded or there is an opportunity for another use), community inclusion, and whether this is the right investment for the community
 - Many concerns raised in regards to a NY Times article questioning the financial viability of Therme
 - o Questions raised around the environmental impact of this development

The Office of the Ombudsman, is a legislatively separate and **independent office under** the State Board of Education that offers confidential and impartial conflict resolution services for families enrolled in District of Columbia public schools.

WHAT WE DO

The Office serves as a resource for families and schools who need assistance resolving school-based concerns. The Office ensures equitable access to instruction by providing policy recommendations to enhance educational outcomes based on observed trends in our casework.

Casework

In over 10 years, we've served over 6,000 families as a bridge for communication between schools and families, addressing education-related concerns and complaints, and evaluating them thoroughly to improve outcomes.

Mayor's Office Update | Presenter: Wendy Glenn

- Presented an overview of the Mayor's FY26 budget, highlighting Ward 8 investments:
 - Housing: \$120M for redevelopment
 - Schools: Modernization across several schools
 - Recreation: \$36M for facilities and libraries
 - Transportation: \$199M citywide, \$21M Ward 8
 - Public Safety: \$45M for 7D HQ renovation
- Final Budget Vote: July 15, 2025
- Residents encouraged to submit testimony by June 17

Commission Votes

- Cmr Moore moved a motion to approve the February and March 2025 agenda meeting minutes, seconded by Cmr. Davis. Vote passed unanimously.
- Cmr. McKinney moved a motion to support the Go Go Museum's 45-day temporary ABCA liquor license for the 45-day period, seconded by Cmr. Davis. Motion passed unanimously.
- Cmr. McKinney moved a motion to support the \$ 1,500 grant application for the Juneteenth Jubilee contingent upon OANC approval, seconded by Cmr. Donohue. Motion passed unanimously.
