Here's a recap of the key questions and comments that were discussed in December 2025's meeting:

- **Contact 3D and 4D Commanders to present before the Committee.** They can answer questions about MPD is dealing with the federal task forces and their efforts to restore trust among the community
- **What's the goal of the Public Safety Committee for next year?** Could it be about working on building trust between public safety agencies during this interim period? We could pressure agencies again to do a Public Safety Summit - which did not get off the ground this year despite our best efforts.
- **Contact Deputy Mayor Appiah to learn who will be interim chief and to stress that that we should not have changes in 3D/4D leadership during this period given that we finally have some leadership stability in these roles**
- **Draft a resolution/letter on the lack of USAO Superior Court reports.** The USAO sent a September report after we asked but cease any updates afterwards.
- **Juvenile Justice issues.** The "peaks and valleys" of juvenile justice trends in DC suggests that there's no long-term strategy. Just reactionary policies. Can we talk to DC agencies and other cities about a long-term strategy that works?

- **Reforming the Citizens Advisory Councils.** This was discussed in ATD's earlier resolution passed this year and still seems like a meaningful project. The CAC meetings seem to mostly just be about people lodging complaints to the Commanders...which is fine, but is there any other purpose they could serve?
- **Stabilization Center.** No new news. The plan is still for it to open in September 2026.
