ANC 1E CY2025 Annual Report

Dear ANC 1E Community,

ANCs are required to submit an annual report summarizing the activities of the Commission in service to the community over the preceding year. The information below outlines issues voted upon, comments submitted to District agencies, and other key activities by ANC 1E in 2025. ANC 1E KEY HIGHLIGHTS:

Communications and Community Engagement

In 2025, ANC 1E strengthened its communications and digital outreach to better inform residents and increase participation in decisions that affect them.

- **Expanded the monthly newsletter** to include neighborhood and community events alongside ANC updates and meeting notices. The mailing list grew to 407 total contacts—an 18.3% increase over last year—with 369 active subscribers (+13.9%).
- **Enhanced the ANC 1E website** with improved accessibility, added resources, and clearer information about the Commission and its members. The site saw 8,900 page views and 3,200 unique visitors in 2025, up 47% and 33%, respectively.
- **Modernized ANC 1E's social media presence** on X (formerly Twitter) and Bluesky to improve outreach and transparency.
- **Branded and better utilized the ANC 1E YouTube channel** to make it easier for residents to find and watch recordings of prior meetings. Over the past year, the channel logged 249 views and 81 hours of watch time, a 135% increase in viewing duration compared with the prior year.
- **Established a consistent communications schedule**, including “save-the-date” notices for general meetings distributed roughly one month in advance.
- **Introduced public press releases** to keep residents informed about ANC 1E actions and community issues.
- **Selected by the Office of Advisory Neighborhood Commissions (OANC)** to pilot a new standardized website format to be implemented across all ANCs District-wide.
- **Park View Power Reliability:** Responded to a year of recurring power outages by filing a formal complaint with the Public Service Commission (PSC) and urging that Case No. CLT-01873 remain open. ANC 1E rejected PEPCO's initial explanation as inadequate and pressed for a detailed root-cause analysis, infrastructure plan, and measurable reliability commitments. The Commission's sustained advocacy led to equipment replacements, load rebalancing, and stronger engagement from both PEPCO and PSC staff.

- **Public Safety on Georgia Avenue:** Worked with MPD, Councilmember Nadeau's office, and city officials to draw attention to resident concerns about crime and safety along Georgia Avenue NW, particularly near Otis Place. Participated in safety walks, in-person briefings, and virtual meetings that resulted in increased patrols and improved coordination among agencies and neighborhood stakeholders.
- **Park View Recreation Center Lead Concerns:** Partnered with Councilmember Nadeau and District agencies to address potential lead hazards at the Park View Recreation Center playground. Participated in multiple in-person briefings, site tours, and community conversations with City officials and residents to verify corrective actions and ensure transparency throughout the remediation process.
- **KC Lewis Redesign and Development:** After securing \$1.2 million in the FY25 budget, worked with Department of Parks and Recreation (DPR), DC Public Schools (DCPS), and other city officials to begin the design and community feedback process for the playground and lower sports fields. As of December 3, 2025, we coordinated with DPR, LeDroit Park Civic Association, and Seaton Elementary PTO to host two community meetings and a survey that received more than 90 responses.
