- Monitoring potential federal government shutdown and related impacts. Local government operations exempt.
- Council finalized RFK Stadium deal.
- Juvenile curfew extension on weekends advanced. Second vote expected October 7.
- Approved 13 percent pay increase for MPD officers to support recruitment and retention.
- Continued oversight of OUC 911 operations.
- DPW leaf collection briefing for Commissioners scheduled for Tuesday, October 7 at 5:30 p.m. Bagged leaves require 311 requests.
- Streateries must comply with new rules. Businesses should schedule November 1 removal if not retaining structures.
- DPW staffing and equipment challenges noted. Leadership vacancies under recruitment.

- Buffalo Billiards, proposed for 2012–2022 14th Street NW in ANC 1B. Capacity noted at approximately 500. No action taken. Committee to seek briefing and monitor hours and late-night egress.
- Detroit Brick Pizza Co., 1626–1630 14th Street NW. Discussion included zoning context and linked concept with Electric Jane.
  - Motion: Protest Detroit Brick Pizza Co. Class C Tavern application based on peace, order, and quiet to preserve standing. Representative designated.

**Public Safety Committee (PSC) Report,** *Commissioner John Fanning*, No September meeting due to holiday. Planning a public safety forum at Washington Plaza Hotel for late October, tentatively October 29.

- Discussion noted increased police response near recent camera deployment and shoplifting reporting practices.
- Commissioners urged residents and retailers to report incidents to MPD to ensure accurate data.

#### Community Development Committee Report, Helen Kramer,

- Zoning variance request discussed for the Uptown Arts overlay related to linear frontage limits on eating and drinking establishments.
- Concerns cited about trash, egress, alley use, and potential live entertainment impacts.
- Applicant requested postponement at a prior CDC session. No motion taken at that time.
