MATTER	COMMISSIONER
 As of 9/3/2025, DC Health reported to Commissioner Baker that there have been 10 cases since January 1 of "potentially dangerous dog" or "dangerous dog" situations; one case from July and one case from August were still open as of that date. The Department of Health is the agency responsible for making the legal determinations, and they can provide the most authoritative guidance on how the definitions are applied in practice. BVSPCA does the initial investigation and passes that investigation packet to DOH for determination and continuing the process.
