Beth Mellen provided a slide presentation on the OAG's Public Advocacy Division and its different sections (Antitrust and Nonprofit, Civil Rights & Elder Justice, Consumer Protection, Housing & Environmental Justice, Workers' Rights & Antifraud, Equitable Land Use). OAG Mediation tries to resolve consumer and tenant complaints without the need to go to court; it is a free service. She also noted they are able to bring lawsuits against landlords and provided some examples. ## 11. REQUEST FOR SUPPORT FOR SPECIAL EXCEPTION AND AREA VARIANCE (471-473 H STREET NW)

Zach Williams, Venable, LLP Mark Freeman Howard Bongam, Developer

**MOTION:** The Commission voted to APPROVE (7 yeas – 0 nays – 1 abstention [Commissioner Watts]) a resolution conveying to the DC Board of Zoning Adjustment ANC 6E's support for the application for special exception and area variance for 471-473 H Street NW. (Motion by Commissioner Abu-Khalaf, Second by Commissioner Hans).

### 12. PEPCO UPDATE ON MOUNT VERNON SUBSTATION

A Pepco representative provided an update on the Mount Vernon Substation and stated construction was completed in 2023 and the substation was energized last year. Other features to be added to the site will include an artistic fence called "Illuminated Legacy" that will feature prominent figures who have had a significant impact across the District as well as artistic murals to be painted on the front of the substation after community feedback is received via a survey. He also provided details regarding Pepco's Customer Relief Fund to help residents with rising energy costs. A question-and-answer period followed.

## 13. RESOLUTION IN SUPPORT OF THE FAIR HOUSING PRACTICES AMENDMENT ACT OF 2025

**MOTION:** The Commission voted to APPROVE (6 yeas – 0 nays – 2 abstentions [Commissioner Rogers, Commissioner Hans]) ANC 6E's support for a resolution that calls on the DC Council to pass the Fair Housing Practices Amendment Act of 2025 after amending the definition of the term "utility" to include internet services in common spaces. (Motion by Commissioner Abu-Khalaf, Second by Commissioner Alhadeff).

## 14. ZONING APPLICATION TO AMEND PLANNED UNIT DEVELOPMENT AT 450 5<sup>TH</sup> Street NW – Case No. 78-17A (Judiciary Plaza, LLC)

**MOTION:** The Commission voted to APPROVE (8 yeas – 0 nays – 0 abstentions) a resolution that conveys to the Zoning Commission ANC 6E's support for approving the zoning application to amend the Planned Unit Development at 450 5<sup>th</sup> Street NW, while encouraging the developer to explore opportunities to increase the share of affordable housing in the proposed development project. (Motion by Commissioner Abu-Khalaf, Second by Commissioner Prince).

## 15. REQUEST FOR SUPPORT FOR PROPOSED ART INSTALLATION – 200 BLOCK OF K STREET NW [6E01]
