 OPENING RECEPTION: \$500-\$600 FOR REFRESHMENTS, CATERING, AND LIVE MUSIC.


### **GALLERY FEES**

- SOCIAL MEDIA AND ADS: \$50-\$750 DEPENDING ON THE MARKETING STRATEGY.





## **Commission Votes**

- Cmr. Donohue moved a motion to reimburse Commissioner White for the GoDaddy domain, name, and the laptop charger for Commissioner Foreman's laptop under the office supplies budget, seconded by Cmr. Davis. Vote passed unanimously.
- Cmr. Davis moved a motion that ANC 8A support the construction of a 40-unit affordable building at 815 Minnesota Ave SE in partnership with House of Ruth, to address the urgent need for affordable housing in our community, seconded by Cmr. Foreman. Vote passed unanimously.
- Cmr. Davis moved a motion to approve the May 2025 meeting minutes, seconded by Cmr. Redman. Vote passed 6-1-0 (one abstention).
- Cmr. McKinney moved a motion to support the \$1,000 Grant application for Elemental Studios for their Youth Exhibition at Anacostia Art Center (grant approved by OANC), Cmr. Davis Second. Vote passed 6-0. Cmr. Moore recused herself because of a conflict of interest.

**Adjournment:** Cmr. White moved to close, and the motion passed unanimously. Meeting adjourned at 7:04 PM. The Next regular ANC8A meeting is scheduled for the first Tuesday in September, with a recess in August.
