## \$750 Grant Request | Youth Back to School Event | Corey McSwain

Corey McSwain is one of the Ward 8 youth leaders here in the Ward 8 area and a youth organizer. I was going to attend Thurgood Marshall, but I changed my mind and decided to attend Friendship Technology Preparatory Academy. Hosting my back-to-school event on August 16th for the youth because some of the youth I go to school with cannot afford back-to-school supplies. We need support for tables, equipment rental, and tools.

Note: The OANC has reviewed the grant, and the funding would be awarded to the Devon McNeal Foundation.

#### **Commission Votes**

- Cmr. Foreman moved a motion to purchase business cards for \$250 / per Commissioner for a total of \$1500 from our office supplies budget, seconded by Cmr. Davis. Vote passes unanimously. Note, the printer is a local W5-based business.
- Cmr. Davis moved a motion to approve the May 2025 meeting minutes, seconded by Cmr. Redman. Vote passed 6-1-0 (one abstention).
- Cmr. Moore moved a motion to reimburse Commissioner Donohue for \$322 for his communications cost (allowable by OANC) under the communications budget line, seconded by Cmr. Davis. Vote passed 5–0–1 (Donohue abstained). Note: Commission committed to setting a budget for individual Commissioner communications, such as the website.
- Cmr. Davis moved a motion to support the \$750 Grant application for the Kid President annual Back to School Bash under the Devon McNeal Foundation (grant approved by OANC), Cmr. Donohue seconded. Vote passed 6-0.
- Cmr. Foreman moved a motion to reallocate \$3000 to the communications budget line from the office supplies budget line, seconded by Cmr. Davis. Vote passed unanimously.

**Adjournment:** Cmr. White moved to close, and the motion passed unanimously. Meeting adjourned at 7:23 PM. The Next regular ANC8A meeting is scheduled for the first Tuesday in September, with a recess in August.
