Report from Metropolitan Police Department:

2nd District Report (Lieutenant Luke Bennett)

- **Total reported crimes:** 38
- **Breakdown of crimes:**
 - 7 on duty side
 - 6 thefts
 - 1 stolen vehicle
- **Specifics:**
 - 1 report of theft at CVS (resolved with arrest).
 - Other thefts included package thefts and thefts from autos.
 - Reminder:
 - Secure packages and avoid leaving valuables in vehicles.
 - Use Amazon lockers for secure delivery.
- **Notable incidents:**
 - ADW knife incident at Thomas Circle (ambulance delay in report).
 - Pending investigation on suspects involved in a narcotics dispute.

3rd District Update (Lieutenant Gavin Harrell)

- Crime statistics for PSA 307 over the last 30 days:
 - **ADW (Assault with Dangerous Weapons):** 0 in last month compared to 1 last year.
 - **Robbery:** 1 incident (86% decrease vs. last year).
 - **Burglary:** 0 incidents.
 - **Theft of Autos:** 6 reported, down from 18 last year.
 - Motor Vehicle Theft (20 last year, 1 this year).
