## ANC 5E Public Meeting Minutes (December 2025)

**Tuesday, December 16, 2025**

1. Commissioner Imtiaz provided instructions for public participation in the meeting.
2. The meeting was held in virtually via Zoom and began at 7 p.m. ET with a quorum with 3 Commissioners present (ANC 5E is composed of 6 Commissioners with 1 SMD currently vacant, such that 3 Commissioners constitute a quorum).
3. Commissioner Vining moved to approve the consent calendar with the December 2025 Meeting Agenda and the November 18, 2025 meeting minutes. Commissioner Gardiner seconded the motion.
