Office of Councilmember Wendell Felder-Letisha Vinson (Updates)

There will be more community meetings regarding RFK redevelopment, your engagement and input really matter. The Fort Dupont Ice Skating Rink had their inspection. There will be a reduction in January and a termination in March regarding the streetcars. Every first Friday of the month Councilmember Felder will be meeting and greeting with the neighbors at Denny's on Benning Road from 10 am -12 pm. Constituent Services Team (CST) has a office in the DGS building where the new post office is located on Minnesota Ave., by Safeway.

Office of Mayor Muriel Bowser-Latisha Atkins

The mayor and others did a tour at the Fort Dupont Ice Skating Rink to make sure there were no major concerns about the opening. About 25,000 district residents may no longer be eligible for Medicaid due to the federal changes. On November 1st, the juvenile curfew legislation was extended. Under the curfew, juveniles under the age of 18 are subject to a curfew beginning at 11pm until 6am. Hypothermia season began on November 1, through March 31st, if you see anyone that's unhoused out in the extreme cold, please call 202-399-7093 or 311. There's a survey out that the Deputy Mayor for Education is hosting concerning a dual language middle school.
