I. Opening Business

Call to Order

Chair Phinizy called the meeting to order at 7:03 pm.

Approval of Minutes

Commissioner Grunewald moved to adopt the minutes of the January 26, 2026 meeting as amended with leave to make technical corrections. The motion was adopted unanimously (7-0-0).

Approval of Agenda

The Chair reviewed proposed agenda modifications, including:

- the removal of a public space permit renewal
- an adjustment of time allocation for the Maret/Friends of the Field discussion
- the addition of time for the Go Vocal discussion
- the addition of a discussion of a letter inviting DMPED to an ANC meeting
- the addition of a report regarding ANC 1B action on the elimination of single-family zoning in DC
- the addition of proposed testimony regarding snow removal and Public Works oversight

Commissioner Gosselin moved to adopt the agenda as amended. The motion was adopted unanimously (7-0-0).

II. Resident Forum and Reports

The Commission received public comments regarding Lafayette Playground maintenance, the Civic Core project, DC Plug undergrounding infrastructure, website access to meeting information, and snow-related service backlogs.

III. Presentations and Motions

Go Vocal Communication Platform

Commissioner Gosselin moved to approve a one-year contract extension with Go Vocal and authorize payment of \$2,100 for the term February 2026–February 2027. The motion was adopted (4-0-3). In favor: Gore, Phinizy, Simmons, Gosselin. Abstaining: Sherman, Grunewald, Nagy.

Maret School Fields / Friends of the Field

The Commission received a report regarding a proposed Community Service Agreement between the Maret School and Friends of the Field regarding the Barrett Fields project.

Snow Removal Resolution

Commissioner Sherman accepted friendly amendments and moved to approve a Snow Removal Resolution as amended. The motion was adopted unanimously (7-0-0).

Commissioner Sherman accepted a friendly amendment and moved to approve related testimony before the DC Council Committee on Public Works, as amended. The motion was adopted unanimously (7-0-0).

Letter to DMPED

The language in a letter from the ANC inviting DMPED to present before the ANC was incorporated, and Commissioner Grunewald moved to approve the amended letter. The motion was adopted (6-0-1). Abstaining: Simmons.

ANC 1B Resolution / Comprehensive Plan

The Commission received a report regarding action taken by ANC 1B concerning elimination of single-family zoning throughout the District. No motion was made.

Ranked Choice Voting

By unanimous consent, the Commission agreed to co-host, with the Chevy Chase Community Association, a February 24 Zoom session on ranked choice voting to which the public is invited.

The Commission received updated information regarding the number and type of apartments proposed for the Civic Core development.
