

**Advisory Neighborhood Commission 6E
Virtual Public Meeting
Wednesday, February 25, 2026**

**8. UPDATE ON PROPOSED DOG PARK IN SINGLE MEMBER DISTRICT 6E09

Commissioner Hans noted that the application has been submitted and is currently under review by the Department of Parks and Recreation. If approved, the next step will be to consider potential names for the park, and he welcomed suggestions.

MOTION: The Commission voted (6 yeas – 0 nays – 0 abstentions) to create an Executive Director position and an Executive Director Trainer position, with the Executive Director Trainer staying only through the end of 2026, with more details about the job description and the job applications to be ironed out in the coming weeks. (Motion by Commissioner Hans, Second by Commissioner Rogers).

MOTION: The Commission voted (5 yeas – 0 nays – 1 abstention [Commissioner Watts]) to support and approve amending ANC 6E's budget to accommodate the Executive Director position and the Executive Director Trainer position and to allocate up to \$3,000 a month through the end of Calendar Year 2026.

SAFETY IMPROVEMENTS AT M STREET AND NORTH CAPITOL STREET NW

He followed up with DDOT on ANC 6E's interest in having them removed and was informed that they would be removed and signage would be posted instead. This was encouraging because the rumble strips were causing noise that disturbed some residents.
