4. UPDATE FROM WARD 6 COUNCILMEMBER ALLEN'S OFFICE

Jeanne Mattison reported on the following topics: **(1)** 2025 Brickies Awards Event on 12/4/25; **(2)** Passage of Councilmember Allen's Emergency Streeteries bill; **(3)** Council extension of juvenile curfews with some limits; **(4)** Council voted to extend the authority to the Mayor and Chief of Police to declare time and geographic limited juvenile curfew zones until Spring; **(5)** Public Hearing to expand DPR hours and field access for youth sports. MOTION: The Commission voted (5 yeas – 0 nays – 0 abstentions) on a resolution that ANC 6E supports the Krewe of Pyros Second Line Parade on Saturday, January 31, 2026 and has no concerns about road closures associated with the Parade. **9. PEPCO PRESENTATION ON RECENT UTILITY BILL INCREASES AND OPPORTUNITIES FOR UTILITY COST ASSISTANCE

A slide presentation was provided that addressed major factors behind utility bill increases as well as ways that residents can get help with their energy bills. A question-and-answer/comment period followed.

**10. PRESENTATION FROM DDOT ON NOI-25-281-MSED NO TURN ON RED (NTOR) RESTRICTION AND LANE RECONFIGURATION AT THE INTERSECTION OF 7TH STREET, NEW YORK AVENUE AND K STREET NW
POC: Azadeh Norouzi**

A slide presentation was presented that provided an overview of DDOT's NOI-25-281-MSED No Turn on Red (NTOR) restriction and lane reconfiguration at the intersection of 7th Street, New York Avenue and K Street NW and other improvements in order to improve motorist and pedestrian safety. A question-and-answer comment period followed.

MOTION: The Commission voted (5 yeas – 0 nays – 0 abstentions) on a resolution that expresses ANC 6E's support for the DDOT Proposed NOI-25-281-MSED No Turn on Red (NTOR) at 7th Street, New York Avenue and K Street NW. (Motion by Commissioner Alhadeff, Second by Commissioner Prince).

11. APPLICATION FOR RENEWING ABCA LICENSE (CLASS/TYPE: C RESTAURANT) – REBEL TACO, 508 K STREET NW [6E01]

MOTION: The Commission voted (5 yeas – 0 nays – 0 abstentions) on a resolution that expresses ANC 6E's support to ABCA for the renewal of the liquor license for Rebel Taco at 508 K Street NW. (Motion by Commissioner Alhadeff, Second by Commissioner Rogers).

**12. REQUEST FOR ADDITIONAL ANC 6E SUPPORT FOR THE PROPOSED MASSACHUSETTS AVENUE NW DOG PARK
POC: Commissioner Ritanch Hans**

MOTION: The Commission voted (5 yeas – 0 nays – 0 abstentions) on a resolution that ANC 6E encourages the DC Housing Authority (DCHA) to support the proposed Dog Park between Judiciary House and Massachusetts Avenue NW and that this be conveyed to DCHA. (Motion by Commissioner Hans, Second by Commissioner Alhadeff).

13. OPEN FORUM

- Commissioner Prince encouraged Commissioners, as well as members of the public, to take advantage to comment on the Strategic Bike Plan. Comments are due by December 31, 2025.
- Commissioner Hans provided an update on the 25 E Street Project and the Community Advisory Team (CAT). There was a meeting with a representative of the Mayor's Office and the Department of Housing. It is planned to have our first meeting at the end of January 2026 and there will be a prep meeting prior to that in mid-January to plan an agenda.
- Commissioner Abu-Khalaf stated that at the January 2026 ANC 6E meeting, there will be Officer Elections and an outside person will be asked to oversee the election. The 2026 ANC 6E meeting schedule will also be set.
