Jeanne Mattison reported on the following topics: **(1)** DC Council FY 2027 Budget and controversial cuts to Child Care, Paid Family Leave, Housing Vouchers, Health Care and more; **(2)** Councilmember Allen's efforts to restore the Pay Equity Fund; **(3)** Funding for the Dog Park in MVT; **(4)** Feasibility Study to redevelop the parking garage at 2<sup>nd</sup> and K Streets NW to better connect Cobb Park with that neighborhood; **(5)** Councilmember Allen restored some of the cuts to the Sustainable Energy Trust Fund; **(6)** Inclusion of funding for WMATA's Gold Line which will connect RFK Campus East-West starting from Union Station to Benning Road; **(7)** Common Area Utilities Bill; **(8)** DDOT

installation of crosswalk at 3<sup>rd</sup> & H Streets NW to meet the foot traffic demand for Cobb Park; **(9)** Juvenile Curfew Legislation. A question-and-answer/comment period followed.

**MOTION:** The Commission APPROVED (6 yeas – 0 nays – 0 abstentions) a resolution that expresses ANC 6E support for the Mount Vernon Triangle CID application for the DC Commission on Arts and Humanities Public Art Building Communities Grant. **9. RESOLUTION REQUESTING THE DC DEPARTMENT OF TRANSPORTATION TO ADD TRAFFIC CALMING INTERVENTIONS IN ANC 6E**

- Commissioner Abu-Khalaf reported that ANC 6E has been notified by the Office of Advisory Neighborhood Commissions (OANC) that they are moving 6E to the next cohort of Advisory Neighborhood Commissions to get access to their unified website. A timeline is not yet known.
- Commissioner Prince stated while he did not have a formal report on the Community Advisory Team (CAT) for 25 E Street NW, he wished to acknowledge the recent passing of Nancy Rosen, who was representing the Capital Plaza Apartments and who was a member of the CAT. A memorial service will be held at a future date.
